OUTREACH PROGRAM COUNSELLOR AND CLINICAL SUPERVISOR SCHEDULE OF FEES - PSYCHOLOGIST AND ACCREDITED MENTAL HEALTH SOCIAL WORKER EFFECTIVE 1 JULY 2021

Consultation (US01) – not less than 30 minutes but less than 50 minutes	\$107.15 (GST free)	\$107.15 + \$10.71 GST = \$117.86 GST inclusive
Consultation (US04)– lasting not less than 50 minutes but less than 90 minutes	\$157.30 (GST free)	\$157.30 + \$15.73 GST = \$173.03 GST inclusive
*Consultation (US50) - 90+ minutes exposure therapy consultation	\$236.00 (GST free)	
*Client did not attend US50 exposure therapy consultation (for appointment not cancelled up to 24 hours prior to appointment)	\$141.60 (GST free)	
Client did not attend – not less than 50 minutes but less than 90 minutes (for appointment not cancelled up to 24 hours prior to appointment)	\$94.40 (GST free)	\$94.40 + \$9.40 GST = \$103.80 GST inclusive
Client did not attend - not less than 30 minutes but less than 50 minutes (for appointment not cancelled up to 24 hours prior to appointment)	\$64.35 (GST free)	\$64.35 + \$6.43 GST = \$70.65 GST inclusive
Reports • Care plan and case review	\$97.20 + \$9.72 GST = \$106.92 GST inclusive	
Reports • Annual agreement and supervisor report		\$97.20 + \$9.72 GST = \$106.92 GST inclusive
Risk Assessment and Management Plan (RAMP) / Open Arms Risk Assessment (OARA)	\$48.65 + \$4.86 = \$53.51 GST inclusive	

*** Note that:**

- Extended 90 minute sessions can only be provided by providers who are acknowledged by Open Arms as trained, competent and supported to provide this type of therapy.
- Therapy item number (US50) can only be claimed for the provision of prolonged exposure (PE) therapy or eye movement desensitisation reprocessing (EMDR) that requires a 90 minute extended consultation, as determined by the appropriate treatment manual. If consultations (including trauma focussed treatment) are less than 90 minutes, the appropriate item should be claimed (i.e. a 50+ minute consultation or 30-50 minute consultation).
- Therapy is to be provided in accordance with the *Australian Guidelines for the Treatment of Adults with Acute Stress Disorder and Posttraumatic Stress Disorder* (2013).
- The therapy item is not to be claimed for other treatments provided to a person with PTSD, such as psycho-education and anxiety management, drug and alcohol counselling, interpersonal therapy or psychodynamic therapy. All service delivery may be subject to Open Arms quality assurance processes, including audit.

NOTE: Counsellor reports and all Clinical Supervisor fees attract GST – the GST amount must be included when invoicing
